

ROTHSAY PUBLIC SCHOOL – IN-PERSON SCHOOL LEARNING PLAN

SEPTEMBER 16, 2021 UPDATE

Rothsay School plans to return to typical school operations and programming in 2021-22. This plan has been reviewed by our school board on August 2 and 9, 2021. This plan was developed with the safety, social, economic, financial, and political impact to students, staff, and community in mind.

The following information is guidance on how Rothsay Public School District plans to respond to a safe return to in-person learning in response to the COVID-19 pandemic for the 2021-22 School Year.

Reopening school buildings for in-person instruction in a healthy and safe manner is our main priority for our students, staff, and community. Rothsay School plans to implement measures to slow and stop the virus from spreading – they are contained in this document. While masks are recommended for those ages 12 and under, they are not required at this time.

Goals for this Plan: 1. Safety of students and staff 2. Prioritize in-person learning as we believe this is the way our students learn best.

COMMUNICATION WITH FAMILIES

- Parents and students will be notified of changes and other news within the school by JMC texts and parent/student emails.
- Major communication will be done by the same means.
- Provide parents with Summit contact information for mental health needs.

FACE COVERINGS

- While recommended for those ages 12 and under, face coverings are **optional** within Rothsay School at this time.
- Face coverings are not optional and still **required on a school bus** per federal guidelines. This includes athletic buses as well.

ROTHSAY SCHOOL RESPONSIBILITIES

- HS students will eat in shifts with an “A” and a “B” lunch.
- Seating will be spread out in the lunchroom with a maximum of five to a table for high school students. Elementary students will sit in their grade “pods.”
- Students will be given a handwashing break (at a minimum) in the morning and afternoon.
- Students kept in same grade “pods” during classes, if possible.

- Students will be socially distanced (more than three feet apart), to the extent possible while remaining in regular classrooms.
- Elementary students will continue to be outside when weather permits during recess and before school.
- Ventilation systems will be run on a more frequent basis than what has taken place in the past.
- Students and staff will be screened each morning in their classrooms.
- Temperatures will be taken at lunch.

ROTHSAY SCHOOL STAFF RESPONSIBILITIES

- Staff will continue to educate our students.
- Staff will screen themselves and students each morning.

ROTHSAY BUS RESPONSIBILITIES

- Each bus will be disinfected after each route.
- At this time, all who ride the bus must wear mask per federal guidelines.
- Students will have assigned seating.
- There will be no eating/drinking on the bus.

PARENT/STUDENT RESPONSIBILITIES

- Parents will screen their children prior to leaving for school. A list of screening questions will be given to parents at Open House night on August 23 or contact the office and a copy will be sent to you.
- Students will be kept at home when sick and/or exhibiting symptoms.
- Parents will have students tested when the child exhibits symptoms of COVID-19.
- Parents will remain outside the school at pick up and drop off times.
- Parents will communicate if their child has contracted Covid-19 and adhere to isolation and quarantine guidelines.
- Contact the school if you have an idea to help us improve our plan.
- Contact the school counselor or Summit if your child is experiencing mental health problems.

IN THE EVENT OF A COVID-19 CASE/EXPOSURE

- Rothsay School will follow the direction of the Department of Health and Wilkin County Public Health in reference to exposures and quarantining.

SPECIAL LEARNING SITUATIONS AND LUNCH

- If a student is in a quarantining situation, Rothsay School will work with parents on a blended learning plan that must be approved by the principal.
- If a parent wishes to have a lunch for their child, notify the office by 10am and pick-up will be between 12:15 and 12:30 at the back of the school.

- If a student requests a blended learning plan – that plan must be approved by the principal and will involve some in-person activities. These requests will only be granted in extenuating circumstances.

ROTHSAY SCHOOL IS COMMITTED TO PROVIDING A SAFE ENVIRONMENT FOR STUDENTS, STAFF AND COMMUNITY MEMBERS. WE BELIEVE IT IS IMPORTANT THAT WE ALL REMEMBER TO RESPECT THE DECISIONS AND ACTIONS OF OTHERS IN OUR COMMUNITY WHILE WE SEEK THE COMMON GOAL OF A SAFE ENVIRONMENT.

WE WILL CONTINUE TO ACTIVELY MONITOR OUR LOCAL COVID DATA TO DETERMINE STRATEGIES NECESSARY TO ENSURE THE SAFETY OF OUR STUDENTS AND STAFF.
